Lifting heavy objects	<ul style="list-style-type: none"> • Do not move or lift objects unless necessary • Use mechanical aids, or handle with a number of people. Break up the load into smaller parcels. • Use good lifting technique. 	<p>Stop immediately if suffering any pain or discomfort. Seek medical attention if ill effects persist.</p>	<p>If volunteers find large/heavy objects, make a note and report to the local council for removal after the event.</p>	
Chemicals	<ul style="list-style-type: none"> • Do not approach or remove containers which contain/contained chemicals 	<p>Seek medical attention if exposed to pesticides, insecticides or other chemicals – record any label details.</p>	<p>Contact the Environment Agency 0800 80 70 60.</p>	
Steep slopes	<ul style="list-style-type: none"> • Avoid picking on or close to the edge of steep slopes etc • Take weather conditions and possible weather changes into account 	<p>Seek medical treatment in the event of injury.</p>	<p>Instruct volunteers to stay away from these areas.</p>

Refuse, litter	<ul style="list-style-type: none"> • Pick up only general litter. • Wear gloves and use a litter picker wherever practicable and available. • Volunteers should not over fill the collection bags. • Volunteers should be briefed to wash hands before eating/drinking/smoking. • Volunteers should take care when collecting sharp or pointed objects e.g. glass or metal. 	Seek medical attention for any cuts. Keep anti-tetanus injections up to date.	Volunteers must wear the safety clothing provided.	
Hypodermic syringes / Drug paraphernalia	<ul style="list-style-type: none"> • Volunteers must not collect needles or drug paraphernalia. If found, the location should be noted and reported to Maidstone Borough Council for collection. 	If a needle stick injury is received then volunteers are to seek immediate medical treatment. Wound should be encouraged to bleed.	Instruct volunteers not to collect any needles or medical waste.	
Tools & equipment	<ul style="list-style-type: none"> • Team to be shown how to use equipment if appropriate. • Allow sufficient working area for the correct and safe use of the tool. • Use appropriate protection. 	First aid training. Have first aid kit available. Obtain medical attention in the event of injury.	Volunteers must use the equipment provided and as instructed.
