# CHAIRMAN'S REPORT

As highlighted previously. Staplehurst Parish Council takes a proactive approach to the provision of services with the aim of improving the quality of life in the Parish. The street cleaning service is now fully established, we have recently provided additional salt bins in anticipation of further severe weather this winter and we are taking steps to install more planters. One area that the Parish Council takes very seriously is the safety and security of residents which we believe is fundamental to the maintenance of a high quality of life. This is why the Parish Council has agreed to install two Stryker PoleCat cameras in the village. These represent the latest technology and are supported by the Police and Maidstone Borough Council with whom we are working very closely. The cameras are capable of being moved around, but will initially be installed at the Parade and Jubilee Field.

The Parish Council is currently preparing its budget for 2012/13 and the resultant Precept. One issue that has given us cause for concern is the level of grant that the Parish Council receives for concurrent functions. This grant covers the cost of services which in the town areas are provided by Maidstone Borough Council itself. MBC has proposed major changes to the system and Staplehurst Parish Council has played a major role in ensuring that equitable transitional arrangements are in place for 2012/13.

Sadly, I have to report that Councillor Jack Davidson has had to resign due to work commitments and I should like to take this opportunity to wish him all the very best for the future and thank him for the contributions he has made. We are currently seeking a successor through the co-option process. The Parish Council welcomes any feedback from residents on any issues of concern.

# **TWO SUPERMARKET PROPOSALS FOR STAPLEHURST**

Both Sainsbury and Tesco have announced plans to build a new supermarket here in recent weeks.

DK Holdings and Sainsbury's Supermarkets Ltd have proposed a mixed-use scheme on land near Staplehurst station, now used by DK Holdings and GMS Flooring. It would provide a new 28,000 sq ft factory for DK Holdings and a new Sainsbury's store to serve the local community. with approximately 19,000 sq ft of sales floor space. Access to the proposed supermarket would be by a new roundabout in Station Road.

The Tesco scheme on Station Approach would provide a store about the size of the Tesco in Tenterden, focused on providing food for the main weekly shopping trip and a petrol station. In addition, there would be improvements in access to the station, in conjunction with Network Rail and Southeastern Railway, including a new secure car park and new bus stopping facilities.

#### CORE STRATEGY

The Core Strategy provides the overall framework to guide development. Public consultation between Maidstone Borough Council (MBC) and Staplehurst took place on the 14th September 2011. The meeting was attended by a majority of members of the Parish Council and the Rural Settlement Group (RSG) with some local residents.

The Parish Council has since formally responded to the consultation - see http://www.staplehurstvillage .org.uk/rural\_settlement\_group.aspx. It is our perception that the current draft shows a bias towards the Town Centre to the detriment of Rural Areas. MBC plan to run a post-consultation conference in the forthcoming months and a further formal consultation process in February 2012.



Staplehurst Parish Council will not be able to make any official comment or recommendation on these proposals until planning applications have been lodged with Maidstone Borough Council and a response has been considered at a Parish Council planning meeting.



It is imperative that Staplehurst as a Rural Service Centre clearly states its position. The RSG continue to keep a watching brief on all developments paying particular attention to the proposed National Planning Policy Framework and the Neighbourhood Planning Regulations, which seek to encompass a community's 'right to build'. In the meantime the RSG continue to work on the draft Staplehurst Neighbourhood Plan which eventually will be subject to a Local Referendum.

# COMMUNITY SHELTER EXERCISE

Although the date had previously been agreed with the Staplehurst Emergency Help Team, few of us knew anything of the scenario that KCC Emergency Planning Team had put together to test our abilities to respond to a local emergency situation. "Exercise Parish Pump" began with a telephone call to the Parish Council/SEHT emergency mobile at 9 a.m. on Saturday 8th October. Outline details of the scenario were relayed down our telephone tree for help to set up a Community Shelter at the Youth Club as soon as possible. Within 10 minutes the first members arrived. KCC Officers briefed volunteers to play the part of "evacuees" to make the exercise more realistic. We immediately set about organising the Youth Club into a centre where people with varying needs could be cared for in the initial aftermath of an evacuation.

We had been told that an traffic accident on the railway bridge had resulted in a fatality, with a van on fire and potential for explosion of gas cylinders on board. The major emergency authorities were dealing with the crash scene, road closure and evacuating people within a 200 metre exclusion zone. Our part was to deal with the displaced people who couldn't carry out their normal lives. Some needed medical attention by the British Red Cross first-aiders who had been called in, but others just needed a place of safety to take stock of what had happened to them and to receive help to make

alternative arrangements for the next 24 hours until access to their homes, railway and road could be restored. The SEHT members set about their given tasks with enthusiasm.

Throughout the morning KCC staff gave us "updates" of how the emergency situation was unfolding and what we should expect next. At the end of the morning we then had a debrief and reviewed our performance. The feedback from KCC was very positive and the evacuee volunteers also said how well they had been cared for. The SEHT members learned many useful things which would assist us to react even more efficiently should a real emergency situation require local assistance in future.

As winter will soon be upon us, SEHT is now thinking about how it may be able to help elderly or vulnerable people if we have long periods of snow or icy conditions. Several volunteers have already signed up with offers of help to do shopping, drive their 4 x 4 or provide warm shelter to neighbours in the event of power cuts. If you would like to become an SEHT member or volunteer to help in an emergency, please do not hesitate to give your details to the Parish Office. Such information will be stored in accordance with the Data Protection Act and only used in the event of a real emergency, where you could be called upon to help someone in a very positive way, when they need it most.
