A NEIGHBOURHOOD PLAN FOR STAPLEHURST


Staplehurst Parish Council has decided to develop a Neighbourhood Plan.

Neighbourhood plans were introduced by the Localism Act and give communities a chance to plan their local area. Staplehurst Parish Council has applied to Maidstone Borough Council to designate a 'Neighbourhood Area'.

A six-week public consultation, facilitated by Maidstone Borough Council will start on Monday 26th November 2012. For full details please see the letter enclosed with the Update.

TENDERING FOR HEALTH CENTRE CONTRACT – PUBLIC MEETING

The process for awarding a new contract for providing medical services at Staplehurst Health Centre is under way. Staplehurst Parish Council has organised a public meeting on Monday 26th November at 7.30 p.m. at the Village Centre (North Hall) when representatives of the Primary Care Trust will explain the process they will follow and answer questions from the floor. The Health Centre is a vital facility for our village, so please take the opportunity to find out about its future and how it will be affected by changes in the National Health Service.

WAR MEMORIAL IMPROVED

St. Georges Chapel in All Saints Church holds the First World War Memorial. Prior to the war this area was the Lady Chapel and part of the main church. It has its own door to the south of the church. It is not certain why this chapel was chosen to house the memorial but it could be lack of a suitable exterior space, the Martyrs Memorial being at the cross roads. The old school was asked to host the Memorial in their grounds but declined. There was some opposition to the memorial being placed in the church from other denominations and non-Christians.

The memorial was completed in 1918 and rededicated in 1919. The stone tomb that had formed the altar was moved to the front of the chapel and is just to the right of the entrance; the old door, now blocked by this is no longer in use.

The oak carved screening now enclosing the chapel and the commemorative plaque were paid for by public subscription and as many of the names listed come from local farm and land owners they would seem to be the most likely source of income. Mr and Mrs Hanmer gave a further £50 at a meeting in February 1921. Bowman & Sons made the panels and George & Sons were responsible for the paving and masonry work. A committee of local councillors, residents and the Rector organised the whole construction which was not complete until 1921. The Bishop of Dover made the final dedication after completion on All Saints day of that year. Collections were also taken in church and in

November 1921 the sum of £11. 3s 2d was collected.

More than ninety years later, repairs and corrections have now been made to the memorial plaques for those who died in both the First and Second World Wars, and a new shelf to hold wreaths has been made by local craftsman Martin Franklin. A re-dedication service will be held at 12.00 on Saturday 23rd March 2013. Squadron Leader Rev. Steven Lamond from the RAF will be

helping the Rector conduct the service.



NEW SALT BIN LOCATIONS

Staplehurst Parish Council has agreed to provide and maintain three more salt bins in addition to the existing seven. They will be at Bower Walk, Benden Close and Newlyn Drive. The salt is provided for use by residents on pavements at their discretion.

There are also salt bins in Staplehurst maintained by other bodies, particularly Kent Highways.



GETTING THE MOST FROM STAPLEHURST

Kent Libraries want ideas from residents on modernising library services. A presentation at the Parish Council meeting on 1st October explained the search for new and efficient ways to run local library services, meeting financial targets while delivering services that are right for our community.

CHRISTMAS LIGHT DISPLAY

Staplehurst Parish Council has decided to maintain the display of Christmas motifs along the High Street and Station Road at about the same level as last year, and they are to be put up in early December. Trials of low-energy bulbs were not wholly successful – as the bulbs produce

less heat, there were more problems with moisture getting into the bulb holders (particularly in snowy weather) and a higher rate of bulb failures as a result. We will continue to look for ways to improve our energy efficiency without dimming the festive spirit.

MORE DEVELOPERS PRESENT THEIR IDEAS

At a well-attended public meeting on Monday 12th November arranged by the Parish Council, two further developers presented their preliminary ideas for new housing developments in Staplehurst and responded to questions and comments raised by residents. Neither has yet applied for planning permission, and we hope that they will give careful consideration to the issues raised by residents before doing so.

Bovis Homes have an option on land between Fisher's Farm and Headcorn Road. The illustrations presented showed about 162 homes of various types and sizes, including a proportion of affordable housing. A number of the existing landscape features, such as hedgerows and ponds, would be incorporated into the design of the new development. Road access would be from Headcorn Road and Fishers Road, and there would also be access for pedestrians and cyclists at some other



points. Residents raised a number of points, particularly the impact of traffic from the proposed development on neighbouring roads, which are already severely congested at busy periods. Panels showing how the Bovis plans were developed are available for inspection in the Parish Office.

Iceni Projects and Combe Bank Homes outlined proposals for development of a smaller site on the north side of George Street. The plans showed 20 to 25 homes, at a relatively low density. A higher than average proportion would be affordable housing and it was hoped that this would encourage Maidstone Borough Council to grant planning permission for a development outside the built-up area of Staplehurst. Residents were concerned at the risk presented by more people using the footpath level crossing of the railway, and doubted whether George Street was suitable for extra traffic.

CHAIRMAN'S REPORT

In my previous Chairman's report I highlighted the concerns expressed by Parish Councils, including Staplehurst, regarding the proposal by Maidstone Borough Council (MBC) to replace the existing Concurrent Functions Grant with a Parish Services Scheme. I indicated that we were proposing to prepare a petition to be sent to MBC from the Parishes. This petition would require MBC to call the decision in; and if necessary a poll would be taken to obtain support for a differential rating system. I am pleased to state that the petition is now well underway and we already have over 230 signatures. We shall continue to collect signatures; copies of the petition are available at the Parish Office. It is also available on-line at www.tinyurl.com/ParishPetitionToMBC. The complete petition will represent all the Parishes in the Maidstone Borough and is being coordinated through the Kent Association of Local Councils (KALC); we have been informed that they have currently collected over 3400 signatures which is significantly higher than collected on previous occasions. This very important to the future financing of Parishes in the Maidstone Borough; we need your support.

We have now finally received approval from MBC for the installation of a pole and light for the new Stryker PoleCat

security camera at Jubilee Field, which we hope to complete by the end of November. The camera has arrived and we hope that together with the improved lighting it will help to protect all the facilities at Jubilee Field and their users.

The state of the Parade continues to give cause for concern and we are currently pursuing this with MBC. We recognise that, although it is privately owned, it is also a public space that it is an important part of our village; and as such, residents are entitled to a clean environment to go about their business.

The Parish Council is taking steps to prepare a Neighbourhood Plan. This is something that is being encouraged by the localism agenda and once established will set out the specific needs of our community within the overall core strategy of MBC. A Rural Settlement Group (RSG) comprising both residents and parish councillors has been set up and is overseeing this work. MBC is currently publishing public notices notifying our intention; the plan will cover the whole parish and not just the village envelope. We believe this is very important since all parts of the parish could be affected by future development.

Finally, I should mention that our Editor, Councillor Joan Buller, is recovering from an operation. Joan is our longest serving parish Councillor and is a major contributor to the well being of the community. I know that Joan is much missed and we all wish her a speedy recovery.
