# Chairman's Annual Report 2011-2012

This has been an active year for our Parish. The May 2011 elections resulted in a new Council being installed. This Council endorsed the policy of taking a proactive approach to issues and services affecting the well being of the community; and this is reflected in the services provided.

Current services include the provision of street lighting, ownership of Jubilee and Surrenden Fields (the latter on a long lease) and the management of the public toilets. The latter was taken over from Maidstone Borough Council (MBC) and is now well established. New services include the introduction of our own street cleaning service and the installation of state of the art security cameras. We feel that residents should feel secure when visiting our community and these cameras have already had a positive impact on reducing anti-social behaviour. In addition we have funded the implementation of a new drainage system at Jubilee Field. This should enable more effective usage of this important public facility.

The Council continues to make a significant contribution to borough wide issues affecting parishes. We have played an active role in the Kent Association of Local Councils (KALC) and have taken a leading role in promoting the Parishes' interests in the concurrent functions debate with MBC. The concurrent functions grant covers work undertaken by Parishes which in non-parished areas is undertaken by MBC. We recognise that MBC needs to find savings; but this is a major source of funding for Parishes.

In last year's report I mentioned the work of the Rural Settlement Group. This group is made up of both residents and councillors and continues to make an important contribution towards developing a Neighbourhood Plan. I should like to thank John Kelly for his work in chairing this group.

As many will know we have received applications from two major supermarkets to develop and install a new supermarket in Lodge Road/Staplehurst Station area. Staplehurst Parish Council organised and chaired two public meetings and these were very well attended. In each case Staplehurst Parish Council held Council Meetings to discuss and make recommendations in respect of these planning applications. I must emphasise that these meetings were concerned only with planning issues and the recommendations made to MBC Planning Committee were based solely on this criteria.

We have a Finance Group which makes recommendations to the Council in respect of the Council's budget and precept. The cost of maintaining services and the introduction of new services have increased costs. This has put demands on our financial reserves which will need to be increased to meet audit recommendations. The increase in the Parish Precept may seem high in

percentage terms, but it is starting out from a relatively low base and in reality amounts to less than ten pence per week for a Band D property. In comparison with other parishes in the Maidstone Borough Staplehurst remains very much in the middle of the precept range for a Band D dwelling.

I should like to take this opportunity to thank our MP Helen Grant and County and Borough Councillor Eric Hotson and Borough Councillor Richard Lusty for their support. Joan Buller and husband Malcolm continue to do sterling work with Speed Watch which is an important tool in regulating speeding through the village; their work is much appreciated. We also very much appreciate the work of the Police and in particular the role played by our PCSO Pete Gardner. Having a PCSO dedicated to Staplehurst is vital to our community and his contribution is also much appreciated. As many will know our Community Warden Chris Lomax has moved on during the year to a new post. Chris was extremely well known in the village and I should like to take this opportunity to thank him for all his hard work. His position has been taken by Mira Martin who is very experienced in this field and we are delighted she is continuing with this important work.

We welcomed Councillor Sam Lain who was co-opted on to the Parish Council after the May election. I believe Sam is the youngest Councillor in the Borough and quite possibly in the County; this should add to the wide range of experience and expertise which the Council can call on. Councillors Jack Davidson and Steve Smith have left this year and in their place we have welcomed Adele Sharp and Anne Gosling. Sue Bassett who has been Clerk to the Council for over 16 years will be relinquishing her post shortly. Sue has been the linchpin of our operation and will be greatly missed. However, I am delighted to note that she will be returning to take up the position of Responsible Finance Officer (RFO). This is an important position and I am sure Sue's knowledge and experience will be invaluable. I should also like to thank Sue for her support during the year. In her place I am delighted to welcome Mick Westwood who will be taking over Sue's role as the Parish Clerk. Mick is very experienced and has very good knowledge of Staplehurst; we look forward to working with him during the coming year. Finally, my particular thanks go to my two Vice-Chairmen Councillor Tom Burnham and Councillor Paul Kelly for their support and advice and to Councillor Paul Butcher who has successfully taken over as Chairman of our Planning Committee.

In order further to develop our communication process we have recently set up a monthly surgery at the library. We need to hear from you.

### John Perry - Chairman

I work on the Strategy & Policy Group and represent the Council on the Patients' Participation Group at the Health Centre. I am associated with the Kent Association of Local Authorities Area Committee and I have the honour of chairing the Staplehurst Emergency Help Team which this year achieved recognition by MBC and KCC as a partner in emergency.





# Peter Spearink

I am a member of the Planning Committee, the Policy Group and Staplehurst Emergency Help Team. I have attended and reported on numerous conferences and meetings on behalf of the Parish. I continue to represent the parish at the Local Transport Forum in Hawkhurst for better transport facilities in rural areas, recently successful in re-introducing the

full Sunday service on route 5. I represent SPC in contacts with Kent Fire and Rescue Service. I am Chairman of the popular Maidstone Borough Older Persons' Forum.

# Parish Clerk's Annual Report 2011-2012

The past year has been as busy as ever in the Parish Office to support the continuing progress, new activities and responsibilities undertaken by the Council. A large amount of work has been achieved by the Rural Settlement Group, which is monitoring closely the MBC Core Strategy and potential future development in the parish. Pre-application and public meetings were held with potential developers who were left in no doubt regarding the infrastructure needs of the parish. Well-attended public meetings in December 2011 and March 2012 raised many issues around either or both Sainsbury and Tesco building a large supermarket in the parish.

Close partnership-working with the police resulted in the purchase by the Parish of mobile CCTV cameras. These were monitored initially by MBC (but now by Medway) and have already provided the police with useful data to enable arrests. A new street sweeping contract enhances the service provided by MBC. Tiling work at the Bell Lane Toilets has improved the ambience of this building. The Publicity & Website group has continued to upgrade the website and ran the first, and successful, photographic competition. Four editions of the Village Update were drawn up by Councillor Joan Buller as Editor and distributed by volunteers.

Financial support for the employment of a professional Youth Worker has ensured the Youth Club has been opened regularly on Tuesday evenings. The first Staplehurst Skateboard Competition was unfortunately rained off, but will hopefully be bigger, better and drier on 23rd June 2012 in partnership with MBC. Summer Playscheme 2011 was a great success, hopefully to be repeated in 2012. Christmas Light motifs were displayed during December along the High Street and Station Road. Parish salt bin provision has been welcomed, as has the addition of sides to four bus passenger shelters. Much work has also gone into planning the Queen's Diamond Jubilee Parish Celebration by Councillors and local residents. A village clean up was undertaken in March under the auspices of MBC, spearheaded by Councillors Tom Burnham and Joan Buller.

The Staplehurst Emergency Help Team, supported by the Parish Council and local residents has now published the Staplehurst Emergency Plan. Training and practice sessions mean that a community shelter could now be set up very quickly if needed in an emergency. The Caretaker's regular litter-picking around the parish and maintenance of Surrenden and Jubilee Playing Fields were undertaken. This work (and more!) was organised and documented in the Parish Office, by Councillors, the Assistant Clerk, Deborah Jenkins and myself.

After having been in post for over 16 years, I took the decision in January to tender my resignation as Parish Clerk. This was a difficult decision but the need for a better work/life balance took precedence over all other issues. That said, I will remain employed for 2 days per week from May 2012 as the Council's Responsible Finance Officer. Mick Westwood has been appointed as the new Clerk and will work 4 days per week. I am happy to support him in his new role and hope he will gain as much satisfaction as I have, in helping the Council to be active and well-respected for what it achieves. Working closely with a number of wonderful Councillors is quite humbling. Councillors give selflessly of their time and experience for the benefit of the parish, without payment. I just wish a greater number of residents who moan about the Parish Council would take a closer interest in the issues and appreciate Councillors who do such good work for the benefit of Staplehurst.

#### **Planning Committee**

The Planning Committee plays a very important role within our council, discussing every application for building within the parish. We try to be very even-handed, looking at the facts before us and using our local knowledge, debating within the planning guidelines. Our considered recommendations are forwarded with comments to Maidstone Borough Council which makes the final decisions. As these decisions can be life-changing for residents it is very important to be fair and to get it right. Two major supermarkets have submitted plans this year to build near Station Approach which have been a major challenge to the council and our community. A whole evening was dedicated to each application, giving the applicants and the public time to have their say and ask questions before the whole council considered the supermarket schemes because of the importance of these developments to our rural parish. Between April 1st 2011 and March 31st 2012 the Planning Committee has considered:

- 106 Planning Applications
- 6 Tree works
- 3 Appeals

Planning Committee members read all the necessary paperwork and visit the sites whenever possible.

#### Alcohol Control Zone

A group was set up to review the consumption of alcohol in public places in the Parish, particularly by under-age drinkers and associated anti-social behaviour. A number of meetings have been held with MBC, Trading Standards, the Police Community Support Officer and the Community Warden. We came to a conclusion that the most effective solution would be to install state of the art security cameras in key areas of the parish. As a starting point we selected the Parade and Jubilee Field. The latter requires planning permission and as a temporary measure we have installed one of the cameras in Market Street. This has been so successful that we are considering acquiring a third camera.

### Allotments Group

The group has been continually exploring possible sites for a community allotment, and has been in negotiation with three landowners over the past ten months without a positive outcome. In the meantime the search continues. If you know of possible areas please contact the Parish Clerk.

### Finance Group

The Finance Group makes recommendations to Council on expenditure and prepares the annual budget and precept requirement. It reviews the Asset Register, Risk Management and Financial Regulations, together with other reviews, to ensure best practice and careful control of public money. Regular reports are received from the Internal Auditor as part of the internal control process. A review of the internal audit function and its effectiveness takes place annually.

### Hawkhurst Transport Forum

The local transport forum which meets in Hawkhurst has been running for about four years achieving several successes in improving bus services from Maidstone to Hastings. Due to the lobbying by the group Arriva has reinstated a full Sunday service from Maidstone to Sandhurst for a six month trial so it is a case of use it or lose it.

#### Jubilee Field

This is owned by the Parish Council and is an important community facility. It has a number of football pitches, a skate park, a modern sports pavilion and a separate pavilion for the Girl Guides. The Jubilee Field Management Group (JFMG) manages these facilities and the SPC is represented on this Group. In conjunction with the JFMG the SPC has funded the improvements to the drainage of Jubilee Field. It has also contributed to the funding of the UpRockin skateboarding festival to be held at the skatepark.

### **Playscheme**

Play Place, working with MBC and Staplehurst PC, again ran our summer playscheme. Gail and her team successfully organised this using the excellent school facilities. Councillors visited and saw for themselves happy children safely having fun. Play Place will be working with us again in summer 2012.

### **Publicity & Website Group**

This group continues to manage and improve the website in order to make local information more accessible to the public. The Forum has been particularly active in the last twelve months thanks to planning applications. This Group is also responsible for producing four Village Updates and the Annual Report.

#### Queen's Jubilee Celebrations

Parish Councillors have been working with the Jubilee Group to organise a range of activities for the Queen's Jubilee. Several successful fundraising events have taken place, enabling a full programme for all members of our community. We look forward to a brilliant and memorable few days.

#### Rural Settlement Group

This active group of residents and councillors has met throughout the year on a monthly basis. We have attended conferences to obtain a wider perspective on Localism. The Group has continued to monitor developments within the Borough's draft Core Strategy and key policies. The Group has responded to important consultations on the draft Core Strategy and the draft National Planning Policy Framework. The Group prepared a Development Contributions Document which was forwarded to MBC. We have worked on drafting a Neighbourhood Plan for Staplehurst which is aimed at shaping the future of the Village.

### Speed Watch

Major reorganisation now means that every motorist speeding in Staplehurst will have their details recorded on the countywide police database, amalgamating records from every scheme throughout Kent. Staplehurst volunteers work hard and more training is available for new recruits to make our roads safer.

## Staplehurst Emergency Help Team (SEHT)

This year the SEHT volunteers completed their initial training with a realistic exercise last October. The Team is now fully operational and has been accepted as part of the Kent and Maidstone Areas Emergency teams, by both Maidstone Borough Council and KCC; the first to do so in the Maidstone area! We welcome all new volunteers.



## Strategy and Policy Group

This was established to review current Council policies, practices and procedures and where appropriate instigate new ones. In addition it reviews and makes recommendations to the Council in respect of medium and long term strategies.

#### Surrenden Field

A small group of Councillors are working on options for improving the Surrenden Field for all users. The first steps are likely to be better drainage on the south side, near the school, and an all-weather footpath linking Surrenden Road and Bower Walk to Nicholson Walk. Suggestions for further improvements will be gratefully received.

### Village Enhancement Group (VEG)



Two more bus shelters have new sides which are much appreciated by local residents. We have also fitted notice boards in two more and these are well used to give local information.

The Bell Lane toilets have been further upgraded by retiling them and they will be repainted soon.

Eight salt bins have been located around the parish,

proving invaluable in the winter's snow and ice. This is an ongoing project.

Four more planters will soon be installed in A229 locations and in the Marden Road following the colourful displays of the two already in Bell Lane.



We now employ a local mini-scarab sweeper. We hope you have seen it in action and appreciate the improvements to our streets.

The Staplehurst Community Clean-up of the built-up area was very well supported and over one hundred bags of rubbish were removed from our streets. Thank you to all the volunteers who helped. It was a great community effort!

#### Youth Club

The council is still funding the employment of our Youth Worker, Mike King, and the club continues to thrive under his leadership. There have been many improvements to the Youth Club facilities this year.
