# **UPDATE ON SUPERMARKETS**

On January 10th the Maidstone Borough Council Planning Committee unanimously approved Sainsbury's application to build a supermarket in Station Road/Approach as a joint project with DK Holdings.

On the same night the Committee voted against the recommendation to refuse the Tesco's application for a supermarket at Station Approach with a new railway car park in George Street. Although the Planning Officer regarded the new supermarket itself as acceptable, the car park would have breached a MBC policy opposing unsuitable development in the open country. The Committee then decided to defer a decision on the Tesco application for investigation of the layout of the car park and the natural area, mitigation of damage to the open country (including light pollution) and biodiversity.

# OLIVER ROAD SCHEME

Following public consultations and an exhibition of their proposals last year, developers Taylor Wimpey submitted a planning application (MA/12/2106) to MBC last year to build 53 new homes on their site south of Oliver Road (the "Wimpey Fields"). The houses would be a mixture of 2, 3, 4 and 5-bedroom types and would include 40% of "affordable" homes (shared-ownership or rented). The new housing would occupy about one-third of the site with the rest used for a conservation area and community woodland.

The Parish Council's planning committee considered the application at a meeting in December when local residents were able to say what they thought about the plans. Although parish councillors thought there were some interesting aspects they felt that several important requirements had not been adequately addressed, particularly drainage and traffic. There were also issues with the layout of the site such as parking provision and that some of the taller houses were placed overlooking existing homes. Councillors would have liked to see some bungalows included. The Parish Council recommended MBC not to grant the application as it stood. At the time of going to press no date had been set for a final decision by MBC.

The Staplehurst Neighbourhood Plan Public Consultation ended on the 8th January 2013 and two responses were received. Both responses were positive to the idea of the whole parish being the designated area which MBC has now approved. # **BUDGET AND PARISH PRECEPT FOR 2013/14**

Parish Councils have to finalise their budgets and precept calculations for submission to MBC at this time. This year has proved particularly difficult because of the uncertainties surrounding the potential loss of the grant for concurrent functions. We currently receive over £20,000 which would result in a loss of over 20% of our overall income. In addition consideration may need to be given to employing a planning consultant if the Neighbourhood Plan is to be progressed. However, the timing for this is still uncertain since it is tied up with MBC's Core Strategy. Therefore we shall be liaising closely with MBC before any final decisions are taken. Nevertheless some allowance in the budget will need to be made to cover possible additional expenditure.

Clearly we could just increase the precept to reflect the loss of the grant; this would mean an increase of 20%. We also need to take into account possible funding under the new Parish Services Scheme although this is greatly

reduced. We must also review our forecast expenditure to ensure that we are providing a cost effective service. At the time of going to press the precept is not finalised since we have been waiting for MBC to inform us as to the funds available under the new Parish Services Scheme. Based on initial estimates from MBC the grant under the Parish Services Scheme will be reduced by around 60%. Nonetheless we have agreed in principle that the Parish Precept for 2013/14 for a Band D property should not increase by more than about 10% which approximates to about 8 pence per week.

This increase not only allows for the reduction in the grant for concurrent functions, but also covers budgeting for a planning consultant. These additional costs are financed partly through the precept increase, partly from reserves and a one-off support grant from Government; the latter compensates parishes for possible losses associated with the localisation of Council Tax Benefits.

# **GARDEN WASTE SACKS**

MBC is discontinuing the use of garden waste bags in June 2013. You can hire green waste bins in two sizes: 240 litre bin for £30 per year or 140 litres for £27 per year. For those with very small gardens it is suggested that neighbours share a bin. Until then garden waste bags are available at Spuds and Buds, Henhurst Farm Shop and Paxmans Services.

Bidders have until 6th February to bid. The preferred contractor will be recommended by the PCT by 27th March. # SERVICE FOR SGT FITZGERALD - SATURDAY 23RD MARCH

Arrangements for the Service of Remembrance for Sgt Fitzgerald, Staplehurst's missing airman, are well under way. The Mayor and his deputy will attend as well as a representative from the Australian Air Force and hopefully the Italian Air Attache. The Lord Lieutenant of Kent is sending a Deputy Lieutenant. The Brass Quintet of the Central Band of the RAF will be playing and an RAF Chaplain is going to assist the Rector. Sgt Fitzgerald was a member of a Commonwealth crew of South African, Australian and British and although he was in the RAF he

died while flying as a crew replacement with a South African Air Force squadron. The service is to be held on 23rd March at 12.00 noon in Staplehurst Parish Church and the Parish Council are particularly keen to see many local people attending to make amends in this small way for the 66 years that his name was missing from the war memorial which has been restored with his name in its rightful place. Please give your support to show that the present generation still care for the memory of our war dead.

# CHAIRMAN'S REPORT

Recently Staplehurst Parish Council has been involved in a number of important issues affecting our community. Perhaps the issue that has generated most interest is the development of a supermarket in Staplehurst. As already been indicated, at its meeting on the 10 January 2013, MBC's Planning Committee approved Sainsbury's application; but, did not support the Officers' recommendation to refuse Tesco's application. The latter was deferred until a subsequent date. Staplehurst Parish Council spoke in favour of the Sainsbury application and in support of the Officers' recommendation in respect of the Tesco application. We remain concerned at possible development north of the railway and it is our intention to speak at the deferred meeting when it is convened.

We have taken the first steps required to develop a Neighbourhood Plan and MBC have now approved our proposal that the plan should cover the whole designated parish area. Neighbourhood Plans are a key part of the localism agenda. However, there are a number of hurdles that will need to be cleared before a plan can be agreed. We do believe that having a Neighbourhood Plan would enable Staplehurst to manage its own agenda and given that it would be supported by a local referendum it would carry a lot of weight. However, we also recognise that Neighbourhood Plans must ultimately be in line with MBC's Core Strategy so there is still some uncertainty regarding the timing of the Plan. In addition, as other Parish Councils have found out, we recognise that this requires expertise that is not always readily available amongst Parish Councillors and residents so we have

agreed in principle to seek the advice of a planning consultant although before doing so we shall need to liaise closely with MBC.

The third issue concerns the loss of the grant from MBC for Concurrent Functions which currently represents around 20% of our precept. The parishes, including Staplehurst, carried out an extensive petition which asked for support to retain the existing Concurrent Functions Grant and if this was rejected to consider polling residents to support a differential rating system. The latter would mean that parished areas would recover the costs of additional services through their own precepts, but would pay a lower borough wide council tax to compensate for double taxation. The petition was strongly supported and with over 3500 signatures MBC had little option but to call the matter in. As Chairman of Staplehurst Parish Council I was given the honour of presenting the petition to a full meeting of MBC. After quite a long debate it was agreed that the matter should be referred back to the Cabinet for reconsideration. Our argument was that the proposed Parish Services Scheme was over complex, lacked transparency, was unfair to the smaller parishes and above all was unnecessary. Unfortunately the Cabinet did not agree and the Members would not change their position. So we are now only left with the option of accepting the Parish Services Scheme and possibly going for a poll on differential rating. The latter will be considered by the parishes at the next meeting of the Maidstone Area Kent Association of Local Councils (KALC).

We believe that Staplehurst Parish Council should continue to take a pro-active role on issues such as concurrent functions to ensure that the interests of our community are taken into account.
